



## Terms and Conditions

Get Hitched Pty Ltd

- All hirers and drivers must be over 25 and under 75 years old otherwise conditions apply due to insurance.
- Drivers must have held a full driver's licence for a minimum of 2 years.
- The hirer and driver must produce a current drivers license on pick up.
- The hirers towing vehicle must be registered and covered by fully comprehensive insurance throughout the rental period.
- The hirer and driver must abide by all lawful road rules.
- Hirers and drivers must comply with all relevant laws, regulations, rules and by laws regarding the use of off road camper trailer or caravan and pay any fees and charges incurred (including road closures as driving on these will void any insurance).
- The hirer and driver will be responsible for checking and ensuring the tow vehicle is legally able to tow the camper trailer or caravan chosen. If the correct requirements are not met upon pick up, refusal by Get Hitched Pty Ltd will be immediate and hire fees will still apply.
- The hirer and driver will be responsible for all damage and injury, risk and liabilities not covered by the insurance company.
  - To the camper trailer or caravan or caused by the camper trailer or caravan.
  - To any person caused by the camper trailer or caravan.
  - To any property cause by the camper trailer or caravan
- Lease fee and insurance paid is as per agreement with Get Hitched Pty Ltd.
- Rental days are calculated on a calendar day basis. The pick up day is counted as the first rental day and the return day of the vehicle is counted as the final rental day, regardless of pick up or drop off time which is between the hours of 8am and 5pm unless previously around with Get Hitched Pty Ltd.
- The camper trailer or caravan must not be used on any unsealed roads or off road conditions unless authorised by Get Hitched Pty Ltd. (Except gravel and sand tracks in good condition of getting from a sealed road to a camp site within 2km)
- Camper trailers and different caravans have different capabilities therefor will be up to the hirer to disclose the unsealed roads you will encounter.
- The camper trailer or caravan will be returned cleaned inside and outside and in good working order including awning. Any repairs will be deducted from the bond. Any cleaning required will incur and cleaning fee of \$50 per hour to a maximum of \$250.
- Toilet cassette needs to be emptied and cleaned on return, if not a \$100 fee will apply.

- The pull out awning must not be left out in windy conditions or when the caravan or camper trailer is left unattended.
- Replacement cost of any item found to be broken, missing, damage or lost will be deducted from the bond. This includes canvas, zips, windows, flooring, poles, pull out kitchen and any other standard accessories hired with the camper trailer or caravan ie stove, gas bottle, water containers, mattresses, storage containers or any other equipment hired separately eg solar panels, fridge or generator.
- The hirer understands that there is strictly no smoking or accommodating pets inside the camper trailer or caravans.
- The hirer is expected to replace all damaged tyres and rims with the same brand and tyre as currently fitted. Keep tyres suitably inflated.
- The hirer should not overload the camper trailer or caravan beyond its limits.
- The hirer will reimburse Get Hitched Pty Ltd for any damage to the camper trailer or caravan cause by water damage due to submersion.
- The hirer will return the camper trailer or the caravan to the place of pick up by the due date and time. If the camper trailer or caravan is not returned by the due date and time a fee of 1.5 x the daily rate. Daily rate will be charged unless previously agreed by Get Hitched Pty Ltd.
- There are no refunds partial or otherwise and no future credit accrued as a result of early return of camper trailer or caravan or any other hire equipment.
- Hirer will notify Get Hitched Pty Ltd of any developing faults/damage/break down or the even of an accident that may have involved the camper trailer or caravan.
- The hire acknowledges that they are fully responsible for returning the camper trailer or caravan to Get Hitched Pty Ltd in Geraldton including any transport cost incurred.
- The hirer agrees to pay a bond and has been advised that the bond will be returned to them (minus any deductions) within 5 working days.
- The hirer agrees to pay the first \$500 to \$1200 (depending on camper trailer or caravan) of any insurance claim for any damage to the camper trailer or caravan whilst on hire.

#### **CANCELLATION POLICY**

- Cancelling the booking over 90 days prior to pick up;
  - An administration fee of \$150 will apply to the cancellation of the booking.
- Cancelling the booking over and including 30 days prior to pick up;
  - 20% deposit paid on booking will be lost.
- Cancelling the booking 7 days prior to pick up;
  - 100% of the gross rental fee will be charged
- Cancelling due to extenuating circumstances eg; natural disasters, terrorist activity, civil and political unrest, epidemic disease or illness, government mandated obligations, travel restrictions a 12 month credit will be given.
